March 2025 Meeting Minutes March Financial Statement

CALL TO ORDER

The meeting was called to order by the Board Chair, Cheri Warburton, at 4:30 pm. Ms. Warburton welcomed attendees, and the roll call was read by Ashley Wilson, Clerk of the Board.

Mary Biggs made a motion to approve the March Meeting Minutes, which was seconded by Sally McCarthy. (*Unanimously approved*)

PROGRAM REPORTS

<u>Finance</u>: Chris Taylor, Executive Director, presented the March financial statement which showed the Year-to-Date percentage at 75%. The agency's total Revenue comes in at 70.25% and the agency's total Expenses come in at 70.23%. Jerry Boothe made a motion to accept the March Financial Statement, which was seconded by Mary Biggs. (Unanimously approved).

<u>Human Resources:</u> Shelly Farmer, Interim Human Resources Director, presented the Quarter 3 NRVCS Turnover Report Data. Overall, the agency had 71 individuals join the agency and 35 staff leave.

Committee Updates

<u>Community Support Committee</u>: Guy Wohlford reported out on the work session discussion which includes an update on the recent federal block grant audit where the agency received good marks and are considered low risk, the agency received an additional 1.5 million to assist with the Permanent Supportive Housing program.

<u>Crisis Continuum Committee:</u> Susan Richardson reported out on the expansion of the proposed Youth CTH which will host 6 beds and will be greatly beneficial to our area as it will keep kids local as opposed to being sent across the state. Susan continued with an update on the data platform and how the data is used to ensure the agency is responding to mobile crisis dispatch calls in a timely manner.

Executive Director Report:

Chris Taylor, NRVCS Executive Director, prepared a summary of important updates and information including:

- Mr. Taylor updated that the agency hosted the Executive Director of the Governor's initiative, Right Help, Right Now, earlier in the month with a tour of the services and programs that NRVCS provides. The tour went well!
- Provided updates on recent and upcoming stakeholder meetings where collaboration was discussed.
- Through collaboration with the Health Department, a Naloxone Box has successfully been placed at the 401 Peer Center.
- The recent Multi Department Site Visit Audit went well with services receiving high remarks and established as low risk. The agency is awaiting the results of the finance review.
- Mr. Taylor provided an update on recent discussions with the Mountain Empire Board around future focused facility projects.
- Mr. Taylor updated board members on FY 26 Budget priorities and the agency's plan to recoup lost ARPA funds.

EXECUTIVE COMMITTEE REPORT:

Cheri Warburton reported that the Executive Committee met this week, and the meeting went well. Cheri reported that she has begun appointing members to the nominating committee and a slate of officers would be presented at the May meeting to be voted upon in June. Ms. Warburton reported that June will be her last meeting and therefore a Board Chair must be appointed.
